This Voters Guide was prepared by the League of Women Voters of Greater Pittsburgh and the League of Women Voters of Pennsylvania's Citizen Education Fund. The League is a non-partisan organization and does not endorse or oppose any political party or candidate. Its purpose is to promote political responsibility through informed and active participation of citizens in government.

The Voters Guide listings are based entirely on material submitted by the candidates. In cases in which questionnaires were not returned, only the candidate's name and party are listed. Every candidate was asked to submit a photograph; those received are printed.

The guide lists all candidates in the November 7, 2017 municipal general election for Justices of the Pennsylvania Supreme Court, Judges of the Superior Court, Judges of the Commonwealth Court, and Judges of the Allegheny County Court of Common Pleas. Also listed is the candidate for Allegheny County Sheriff and Allegheny County Council candidates. Also listed are candidates for the offices of Mayor of the City of Pittsburgh, even-numbered Pittsburgh City Council districts and odd-numbered Pittsburgh School Board districts. The candidates'

names are listed as they will appear on the ballot. The party of the governor is, by practice, given the first position on the ballot in Pennsylvania.

There are also Special Ballot questions for:

A Proposed Amendment to the Pennsylvania Constitution

The municipalities of: Bethel Park and Monroeville

A Proposed Home Rule Charter Amendment for the City of Pittsburgh

Judicial Retention Election Questions.

Study the guide and choose the candidates for whom you want to vote. You may take the guide into the voting booth to help you. Nothing in this guide should be construed as an endorsement of any candidate by the League of Women Voters.

Voters who are not sure if they are registered to vote should call the county Department of Elections, 412-350-4510. To find out what district you live in call the League of

VOTING IN A MUNICIPAL ELECTION

To vote in this municipal election you must have been registered by October 10, 2017.

Your registration is permanent if

- You did not change your address.

- You did not change your name

PRISONERS' RIGHTS
You are eligible to vote if you are awaiting trial.

If you are a prisoner in Pennsylvania, you are eligible to vote if

- You are registered properly.

- You have obtained an absentee ballot.

- You were convicted of a misdemeanor

IDENTIFICATION REQUIREMENTS FOR NEW VOTERS

If you are a new voter or if you are voting at a polling place for the first time then you must bring your

voter ID card or a photo ID such as a driver's license, student ID or some other form of Federal or State government-issued ID. Some forms of non-photo ID are also acceptable such as a firearm permit, current utility bill, bank statement, paycheck, or government check. If you do not have any acceptable ID then you must be allowed to vote by provisional ballot.

PROVISIONAL BALLOTS

If your right to vote is challenged at the polls on Election Day and the problem cannot be resolved at the polling place, the judge of elections at the polling place should telephone the County Division of Elections. The problem could be resolved by phone if your name appears on the county records. If it does not and you want to try to resolve the problem, then you can go in person to the County Board of Elections (City-County Bldg. Room 700) where a judge from the Court of Common

Pleas will be on duty to resolve election problems. Alternatively you can ask for and vote by provisional ballot. If it is later determined that you were eligible to vote your ballot will be counted. You will be given instructions on how to determine if your vote was counted.

ABSENTEE VOTING

Registered voters who are ill, disabled, or will be absent from the municipality on Election Day may vote by absentee ballot. Completed APPLICATIONS for absentee ballots must be received by the Allegheny County Elections Division by 5 P.M., Tuesday, October 31. Completed absentee BALLOTS must be received back at the Elections Division by 5 P.M. on Friday, November 3. If an emergency arises (unexpected illness or business trip) after the Tuesday application deadline, call the Elections Division 412-350-4520 for information on emergency absentee voting. Proof of emergen-

cy may be required. An emergency application and ballot can be obtained and voted by 5 P.M. on Friday, November 3.

WRITE-IN VOTING

For write-in voting information, check with the workers at your polling place before entering the voting booth.

ELECTION DAY PROBLEMS

If your right to vote is challenged at the polls on Election Day and the problem cannot be resolved at the polling place, the judge of elections at the polling place will (MAY) telephone the county Division of Elections. The problem could be resolved by phone if your name appears on the county records. If it does not and you want to try to resolve the problem, then you will have to go in person to the county Board of Elections (City-County Bldg. Room 700) where a judge from the Court of Common Pleas will be on duty to resolve election problems.

Any disabled voter having questions regarding the accessibility of a polling place should consult the Elections Division at 412-350-4520.

JUSTICE OF THE SUPREME COURT

(Vote for not more than one)

TERM: 10 years **SALARY:** \$206,054

JOB DESCRIPTION: The Supreme Court is the highest court in the Commonwealth and the oldest appellate court in the nation. The Supreme Court's administrative powers and jurisdictional responsibilities are vested with the seven-member court by the Pennsylvania State Constitution and a collection of statutes known as the Judicial Code. Administratively, the courts within the Unified Judicial System are largely responsible for organizing their own staff and dockets; however, the Supreme Court has several committees and boards responsible for writing and enforcing rules for judges, attorneys, and litigants to ensure an efficient and fair judicial review.

Annually, the seven justices receive over 3,000 requests for appellate review.

ANSWER 1: A judge should recuse himself/herself when he/she is unable to quell one's own passion or when a bias exists. Yes, I have recused myself in cases where there is familiarity with the parties involved and/or I felt that there would be a perceived bias. Propriety always suggests that it is more important to create an open and fair perception of neutrality than to allow questions that impugn the judicial process.

ANSWER 2: As a judge, I have worked earnestly to secure equal justice for all: I lead the development of new court procedures that provide necessary legal assistance to pro se litigants; Appointed by PA Supreme Court to 3 statewide commissions all dealing with 'access to justice'; Chaired Allegheny County (AC) Commission on Juvenile Justice, implementing system reforms (published booklet, October 2012) & Under my leadership AC became first court in Commonwealth to practice continuing judicial education.

ANSWER 1: Whenever a circumstance, such as the identity of the parties or their lawyers or the issue presented raises a question in the mind of the judge that could compromise integrity, it is incumbent upon that jurist to engage in a process of introspection. Judges are human beings, subject to the same life experiences from which opinions are generated. The question is not whether you do or do not have opinions; rather the real question is can you set aside those feelings or opinions and judge fairly.

ANSWER 2: Access to justice requires more than an assurance that the courtroom doors be open and accessible to all citizens. To give true meaning to those words, we must insure that they have the legal representation necessary to make that access meaningful. As a former member of the IOLTA Board, I am aware of the breadth of the problem, and the potential to address it through pro bono service. My intention is to substantially expand pro bono legal services to bridge the gap between Legal Aid for the indigent and fee paying clients. An idea I intend to explore is to offer CLE credit for pro bono service.

JUDGE OF THE SUPERIOR COURT

(Vote for not more than four)

TERM: 10 years

SALARY: \$194,422

JOB DESCRIPTION: The Superior Court is one of Pennsylvania's two statewide intermediate appellate courts. This court, which was established in 1895, reviews most of the civil and criminal cases that are appealed from the Courts of Common Pleas in the Commonwealth's 67 counties. The Superior Court consists of 15 judges who serve 10-year terms. The president judge of Superior Court is elected to a five-year term by his or her colleagues. A huge volume of appeals flow to Superior Court from the trial courts. Generally, appeals are heard by panels of three judges sitting in Philadelphia, Harrisburg or Pittsburgh. The court often is the final arbiter of legal disputes. Although the Supreme Court may grant a petition for review of a Superior Court decision, most such petitions are denied and the ruling of the Superior Court stands.

QUALIFICATIONS:

As a judge in the largest Judicial district in our Commonwealth, I've had the opportunity to issue thousands of rulings. I have been appealed only 5 times and have never had a decision overturned. I believe this uniquely qualifies me for the Superior Court.

ANSWER 1: I have recused myself in a criminal matter after hearing argument on a bail reduction motion. It would be inappropriate for me to hear the underlying case because information was revealed during this motion that would be prejudicial to the defendant in his underlying case.

ANSWER 2: As a sitting Judge I always ensure that all parties are treated fairly and equally regardless of the issue before the Court. I also believe it is my duty as a Judge to educate the public and is the reason I take part in many community based organizations. I believe I should be a good example both on and off the bench.

ANSWER 1: Impartial judges are a cornerstone of equal access to justice for all citizens. Recusal is a significant decision and is undertaken only when a judge's impartiality can be reasonably questioned. Circumstances, where recusal might be considered, would be conflicts of interest such as, personal economic gains or losses related to the outcome of a case, the involvement of a family member or friend in a case, or if there was a case that I previously worked on as an attorney.

ANSWER 2: In order to ensure fair and equitable treatment for a fair trial, I make sure that defendants are represented by competent legal counsel who will zealously defend them. If there is a conflict with the Defenders Office, I appoint legal counsel who can fulfill that role. Concerning all litigants, victims, and defendants alike, they come to court for justice and seek a full and fair hearing of the issues. Everyone, regardless of their background, or income level, deserve to be treated with respect.

ANSWER 2: As a judge, on the bench, I can treat self-represented litigants with respect, so they are not intimidated by the legal system. Off the bench, I can speak at seminars and to the general public about the need for all people to have access to a lawyer to protect their legal rights. I can also advocate for state funding for our public defenders. (Pennsylvania is one of only two states that does not provide any state funding to the public defenders' office.)

ANSWER 1: Judges should recuse themselves when their impartiality might reasonably be questioned. ANSWER 2: I believe deeply in our civil service system, but it is far from perfect, in large part because too many litigants do not have the resources to afford legal representation in important classes of cases where such representation is not provided by the state. As a result, I have supported and will continue to support efforts to find ways to bridge that gap, including the "Civil Gideon" movement.

Even if I believed I could fairly decide a case, if there was an appearance that I could not, then I would recuse myself. Public confidence in our system is #1.

ANSWER 2: I will grant petitions to waive court filing fees which would be an unreasonable burden. I will also decide all cases based on the principles

of justice, without regard to how good or experienced the attorneys are representing the parties. Off the bench, I will volunteer to speak at law schools and at Bar Assoc. events promoting pro bono. I would be willing to advocate for more support for equal access. I will work closely with the PA Legal Aid Network with sponsorships for fellows and events.

(Vote for not more than two)

TERM: 10 years **SALARY:** \$194,422

JOB DESCRIPTION: The Commonwealth Court is one of Pennsylvania's two statewide intermediate appellate courts. This court, which was established in 1968, is unlike any other state court in the nation. Its jurisdiction generally is limited to legal matters involving state and local government and regulatory agencies. Litigation typically focuses on such subjects as banking, insurance and utility regulation and laws affecting taxation, land use, elections, labor practices and workers compensation. Commonwealth Court also acts as a court of original jurisdiction, or a trial court, when lawsuits are filed by or against the Commonwealth. The Commonwealth Court is made up of nine judges who serve 10 year terms. The president judge is chosen by his or her colleagues for a five year term. The court generally decides cases in three-judge panels and sits in Philadelphia, Harrisburg and Pittsburgh.

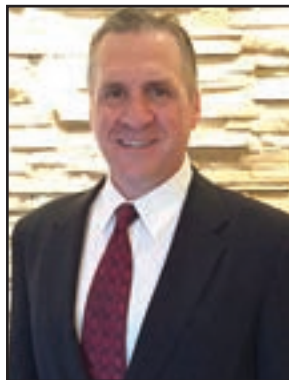

Shall the Pennsylvania Constitution be amended to permit the General Assembly to enact legislation authorizing local taxing authorities to exclude from taxation up to 100 percent of the assessed value of each homestead property within a local taxing jurisdiction, rather than limit the exclusion to one-half of the median assessed value of all homestead property, which is the existing law?

**PLAIN ENGLISH STATEMENT
OF THE OFFICE OF THE
ATTORNEY GENERAL**

The purpose of the ballot question is to amend Article VIII, Section 2(b)(vi) of the Pennsylvania Constitution to permit the General Assembly to pass a law authorizing local taxing authorities to increase the amount of assessed value of homestead property that may be excluded when determining the real estate tax owed for homestead property. If the ballot question is approved, the General Assembly could then

pass a law authorizing local taxing authorities to exclude up to one-hundred percent (100%) of the assessed value of each homestead property when calculating the real estate tax owed on homestead property.

The Pennsylvania Constitution currently permits the General Assembly to pass a law authorizing local taxing authorities to exclude only a portion of the assessed value of homestead property when determining the amount of real estate tax owed. Under current law, the amount of assessed value that may be excluded from taxation cannot exceed one-half the amount of the median assessed value of all homestead property within a local taxing jurisdiction. Local taxing authorities may not increase the millage rate of its real property tax to pay for homestead property exclusions.

The effect of the ballot question would allow the General Assembly to pass a law increasing the amount of assessed value that local taxing authorities may exclude from real estate taxation for homestead property. Currently, local taxing authorities can exclude from taxation only up to one-half the amount of the median assessed value of all homestead property located in the local taxing jurisdiction. But if the ballot question is approved, the General Assembly would have authority to pass a law permitting local taxing authorities to exclude up to one-hundred percent (100%) of the assessed value of each homestead property. Local taxing authorities would continue to be prohibited from increasing the millage rate of its tax on real property to pay for the homestead exclusions.

The ballot question, by itself, does not authorize local taxing authorities to exclude up to one-hundred percent (100%) of the assessed value of each homestead property from real estate taxation. Local taxing authorities could not take such action unless and until the General Assembly passes a law authorizing them to do so. The ballot question authorizes the General Assembly to pass that law.

The powers of the Special Police shall be restricted to situations involving a sudden or unexpected event, which creates a dangerous condition necessitating immediate action. They shall have full police powers and jurisdiction only for the duration of an emergency.

The Auxiliary Police shall be nominated by the Chief of Police and appointed by the Mayor. They shall complete a training course prescribed by the Chief of Police and be sworn. They may only be called to duty by the Mayor and only serve during an emergency.

The duties of the Special Police or the Auxiliary Police may not be used to replace police officers due to a reduction in the Police Force.

If approved, this amendment shall take effect upon the certification of the November 7, 2017 Election results.

Multiple Employment Prohibited, of the Pittsburgh Home Rule Charter be amended to permit a compensated City employee to hold a compensated position as a part-time athletic coach in a public school system or a compensated part-time educational position at a public institution of higher learning, as more fully described in Pittsburgh Ordinance 36?

Explanation of Ballot Question

If this question is approved by a majority of those voting, the Pittsburgh Home Rule Charter will be amended to allow City of Pittsburgh employees to be compensated scholastic sport coaches in part-time positions with a public school district and compensated part-time educational positions in public institutions of higher learning.

For each part-time position, the City Department of Personnel shall develop a strict multiple employment policy and enforcement procedure to ensure employee integrity and compliance.

If approved, this amendment will go into effect upon the certification of the November 7, 2017 Municipal Election results.
